## Order of Meeting

Ted Lawson called the Regular Board of Assessors meeting to order at 4:24 p.m., Minutes from the previous meeting were reviewed by the Board.

The HOA requested information from the Assessor's Office on how property is assessed and requested the Tax Commissioner's perspective on tax law and procedures. The draft is currently in review by the Tax Commissioner for input.
