WR Residual Biosolids Management Request for Bid Recommendation: Water Reclamation Director Kendra Stanciel presented a recommendation for a management contract to haul and dispose of all Residual Biosolids.

Biosolids are the nutrient-rich organic material resulting from the treatment of domestic sewage in a wastewater treatment facility. Biosolids can be recycled as a fertilizer or used as a soil amendment. Biosolids are produced at each of Clayton County Water Authority's Water Reclamation Facilities and require proper disposal.

On June 6, 2021, sealed bids were opened via virtual call for the Northeast and Shoal Creek Water Reclamation Facilities. The bid also provided biosolids management for the W.B. Casey Water Resource and Recovery Facility on an as needed basis in the event the existing pelletizing facility encounters operational or maintenance issues.

The Request for Bid (RFB) included a Small Local Business Enterprise bid discount for vendors that qualified. The RFB also included a 5% bid discount for vendors that could provide beneficial reuse of the biosolids. The following bids were received, and the chart below reflects the bid price, beneficial reuse bid discount, SLBE bid discount and total bid price.

#### Recommendation:

CCWA staff recommends awarding the contract to ERTH Products, LLC in the amount of \$92.00/wet ton to haul and dispose of residual solids from our Water Reclamation Facilities with a renewal option for a 2nd and 3rd year at the same terms, conditions, and price.

If ERTH Products, LLC cannot meet CCWA requirements the Residual Biosolids Management contract would then be awarded to the next lowest bidder, Synagro South, LLC at \$99.00/wet ton.

This award is contingent upon the bidder meeting risk management requirements and executing the contract, as well as the Board authorizing the General Manager to sign the contract.

UPON MOTION by Marie Barber, and second by Dr. Cephus Jackson, it was unanimously

RESOLVED to award the contract to ERTH Products, LLC in the amount of \$92.00/wet ton to haul and dispose of residual solids from our Water Reclamation Facilities with a renewal option for a 2nd and 3rd year at the same terms, conditions, and price. This award is contingent upon the bidder(s) meeting risk management requirements and executing the contract as well as Board authorization for the General Manager to sign the contract.

Noah's Ark and Forest Avenue Tank Painting Bid Recommendation and Memorandum of Understanding: Water Production Director Coty McDaniel presented a recommendation to re-coat and condition the exterior paint on storage tanks.

The Noah's Ark and Forest Avenue Re-pump stations need re-coating and conditioning. This project will not focus on the interior of the tanks but just the exterior. The paint has begun to fade, chip and crack on these tanks.

The work to be performed under the contract generally includes:

- Pressure wash the exterior of all tanks (5) at both locations
- Coat all 5 tanks with Tnemec paint
- Add 2 CCWA logos to Forest Avenue Tanks
- Add 2 CCWA logos to Noah's Ark Tanks

 (Optional) Add City of Forest Park logo to the middle tank at Forest Avenue; City of Forest Park will reimburse CCWA for this cost

#### Recommendation:

CCWA staff recommends awarding the bid to Southern Tank & Tower, Inc in the amount of \$426,750.00, with \$14,000 to be reimbursed to CCWA from the City of Forest Park. This award is contingent upon the Bidders meeting risk management requirements and bonds as well as the Board authorizing the General Manager to sign the contract.

Staff also recommends authorizing the General Manager to sign the Memorandum of Understanding between CCWA and the City of Forest Park for the logo painting on the middle Forest Avenue tank.

UPON MOTION by Dr. Cephus Jackson and second by Marie Barber, it was unanimously

RESOLVED to award bid to Southern Tank & Tower, Inc in the amount of \$426,750.00, with \$14,000 to be reimbursed to CCWA from the City of Forest Park. Authorization from the Board was given to the General Manager to sign the contract.

Hooper and Hicks UV Detail Design and Bid Services Task Order Recommendation: Water Production Director Coty McDaniel presented a recommendation to replace the UV disinfection systems.

Clayton County Water Authority owns and operates ultraviolet (UV) systems to provide enhanced disinfection at all three of our Water Production Plants (WPPs). The UV

disinfection systems were constructed in the early 2000s and are reaching the end of their useful life.

The recent UV Disinfection Assessment & Optimization Strategy project identified operation and equipment issues and provided options for repairing or replacing the UV equipment at each plant. CCWA has decided to replace the UV disinfection systems at both the Hooper and Hicks WPPs to continue providing reliable multi-barrier enhanced disinfection.

The lists below provide summaries of the items to be included in the detailed design:

# **Hooper WPP Improvements**

- Replacement of UV reactors with new Low-Pressure High Output (LPHO) UV reactors capable of conversion to UV-AOP in the future. This includes new lamps, sleeves, reactors, control panels, and other ancillary items.
- Modifications to piping within the UV building, to comply with EPA UV Design Guidance Manual
- New valves and flow meters
- New UV transmittance analyzer upstream of the UV reactors
- Demolition of the existing UV chemical cleaning system
- Demolition and replacement of electrical conduits and wiring
- Access platform and stairway modifications to accommodate new UV reactors, piping, and instrumentation panel layout

# **Hicks WPP Improvements**

- Replacement of UV reactors with new LPHO UV reactors, including new lamps, sleeves, and control panels.
- Modifications to piping within the UV building, to comply with EPA UV Design Guidance Manual
- New valves and flow meters
- New UV transmittance analyzer upstream of the UV reactors
- Demolition of the existing UV chemical cleaning system
- Access platform and stairway modifications to accommodate new UV reactors, piping, and instrumentation panel layout

To meet these goals, the Hooper and Hicks UV Detail Design and Bid Services Task Order includes the following scope of services:

Task 1 - Georgia EPD Design Development Report and 30 Percent Design Services

Task 2 – 90 Percent Design Services

Task 3 – Bid Phase Services

CCWA staff recommends award of Task Order JA-RE-21-05 to Jacob's Engineering in the amount not to exceed \$380,000
