*3. Adoption of Agenda:*

**Motion made by Vice Chair Dorothy Foster Hall, seconded by Treasurer Givens to adopt the agenda. Vote Unanimous. Motion carried.**

*4. Public Comment:* Citizens will be given a three minute maximum time limit to speak before the Board of Elections and Registration about various topics, issues, and concerns. Public comments will be limited to thirty (30) minutes. Following thirty minutes of hearing from the public, the Board of Elections and Registration will allow the remainder of citizens who have signed up to be heard at the next regular business meeting.

*5. New Business:*

*A. Recertification of Election –November General Election held November 3, 2020*

#### *➤ Presidential Race Recount*

Director Dozier informed the Board that on November 23, 2020, the Secretary of State's Office directed each Georgia County Election Offices to conduct a recount of the November General Election for the Presidential Race. The recount was to be completed by December 2, 2020, yet due to ongoing Special Election, it was asked that Clayton County complete the recount prior to the December 1, 2020 Special Election. The recount started on November 24, 2020 and was completed on Sunday, November 29, 2020.

Director Dozier thanked the Registration and Elections staff for sacrificing the county observed holiday (Friday after Thanksgiving) to perform duties associated with the recount process.

Director Dozier informed the Board that the percentages for the Presidential Election stayed the same however there was a 32 vote difference. The difference included nine under votes, ten over votes, and thirteen unresolved votes. The Election Summary Report does not show under and over votes, only unresolved write-ins. As a result of the vote difference Clayton County is required to recertify.

Director Dozier recommended that the Board recertify the November 3, 2020 Presidential Race Recount results to reflect the results of the recount.


