A. Certification of Election- General Primary Runoff Election held August 11, 2020

Director Dozier informed the Board that there was a 3.1% turnout for the Runoff Election. There were no provisional ballots casted during the Election.

Director Dozier informed the Board that 512 votes were casted out of 16,135 eligible voters.

Director Dozier informed the Board that Technician Brown and Supervisor Houston utilized Precinct Managers and Assistant Managers to serve at the polling sites in order to provide additional training and experience utilizing the new voting equipment to prepare for upcoming larger elections.

Motion made by Board Member Pullar, seconded by Vice-Chair Foster-Hall, to accept the recommendation made by Director Dozier to certify the General Primary Runoff Election held August 11, 2020. Vote Unanimous. Motion carried.
