VOTER REGISTRATION:

As of October 1, 2023, there are 207,014 (180,993 Active: 26,021 Inactive) Voters.

VOTER REGISTRATION DEADLINE: The Voter Registration Deadline for the 2023 November General is Tuesday, October 10, 2023.

LIST MAINTENANCE CONFIRMATION NOTICES:

In accordance with O.C.G.A. § 21-2-234 confirmation notices were set for mailing. An estimated 5,895 No Contact (moves to inactive status) and 4,707 No Contact for two General Elections (NGE) (inactive for 2 General Elections) will be removed. Mail Confirmation notices were mailed to impacted voters. The NGE was mailed by the Secretary of State's office and the No Contact (5,985) will be mailed from the county on August 10, 2023. Confirmation notices were mailed to electors whose addresses have changed with the United States Postal Service but do not match the elector's address in Voter Registration and those who we have received returned mail by the US Postal Service or had no contact with election officials for five years through voting, updating their voter registration are among some reasons for two general elections. The file of all voters impacted has been shared on the front page of our website (courtesy of the Secretary of State's site) for public viewing.
