The following report represents a summary and recap of major operations and activities that we have completed or are ongoing within Elections and Registration for the month of December 2023 and activities since the last Board meeting. The priorities were centered on Redistricting, 2024 Pre-Election, and 2023 Post-Election Day activities, processing voter registration applications, open record requests, trainings, performance evaluations and renovations.

PERSONNEL STAFFING:

STAFFING PROFESSIONAL DEVELOPMENT AND TRAINING:

Deadline driven task from the redistribution of daily operations continue to receive priority training which included Staff Training. Since the last Board meeting, the Office Team has undergone their performance evaluations and been submitted to Human Resources.

Recommended hours are Monday – Friday 8:00 AM to 7:00 PM and Sunday Voting as suggested from 12:00 PM – 5:00 PM with the exception of runoff elections.

As of January 1, 2024, there are 208,281 (180,185 Active: 28,096 Inactive) Voters.

Clayton County is required to conduct redistricting activities associated with the recent legislative changes. We began the redistricting process on January 2, 2024 and with the goal of a January 19, 2024 completion in preparation for the March Presidential Preference Primary election.
