The following report represents a summary and recap of major operations and activities that we have completed or are ongoing within Elections and Registration for the month of January 2022 and activities since the last Board meeting.

The priorities were centered on Post-Election Day activities associated with the 2020 June Primary Elections November General & Special Post Election Day request as well as the January 5, 2021 Special and General Runoff Elections, processing voter registration applications, open record requests, confirmation notices, the election activities for the Post - Special Runoff Election and the November General Municipal elections, training renovations, redistricting preparations, pre-election activities associated with the 2022 election year and the rearrangement of elections tasks due to the global pandemic COVID-19.

# ELECTIONS AND REGISTRATION JOB RECRUITMENT FAIR: JANUARY 11 - 13, 2022

The Clayton County Board of Elections and Registration Department conducted a job recruitment fair for temporary/seasonal positions as well as poll officials for the 2022 election year, Tuesday, January 11 – January 13, 2022, from 9:00 AM – 3:00 daily. We recruited Election Day Poll Officials, Absentee Clerks and Managers to work during our absentee voting period as well as Election Day. The Board was provided the flyer to distribute to their respective communities. Recruitment is ongoing throughout the year to fill positions.

# ELECTION CENTER BOARD OF DIRECTORS NOMINATION:

The Election Center Board of Directors' Nomination Committee nominated Director Dozier as a newly appointed Board Member. The Election Center Board of Directors represents an experienced body of individuals bringing together their respective expertise from such diverse fields as business, government, jurisprudence and academia. The conference has been rescheduled virtually for February 10 - 11, 2022. Additionally, the new Board Member panel has been rescheduled for the Special Workshop that will be held in Atlanta, February 23 - 27, 2022.

The mission of the Election Center is to promote and support continuous improvement in the administration of elections and voter registration through research, professional education, conferences, networking and consulting. Director Dozier has been a Certified Elections/Registration Administrator through the Election Center's Professional Education Program since 2016 and looks forward to serving on the Board of Directors.

#### 2022 QUALIFYING FEES AND INFORMATION:

The Board of Commissioners set the qualifying fees at the first regularly scheduled Board of Commissioners meeting in January 4, 2022.

Qualifying for the 2022 Primary/Nonpartisan and Independent/Political Body Candidates for the November General Election is set to commence at 9:00 AM on Monday, March 7, 2022 and end at 12:00 PM on Friday, March 11, 2022. # 2022 ELECTION CYCLE ADVANCE VOTING DATES/TIME:

Ms. Dozier plans to submit a Resolution to the Board of Commissioners in March to set the Advance Voting dates and time for the 2022 Election Cycle pending the Board of Elections approved recommendation.

#### 2022 ELECTION DAY JUDGES:

Director Dozier will provide the list of the 2022 Election Day Judges for the Election Year when the list has been provided.

#### REDISTRICTING:

Governor Kemp signed the redistricting maps into law on December 30, 2021. We have been given a deadline of completion for February 18, 2022. Our current focus is to meet this deadline.

Please be advised that we may need to call a special called meeting in order to ensure we have enough time to make all of our deadlines and get the information out to the public as soon as possible prior to qualifying. This is contingent upon the legislature's decision to maintain the current 2022 election calendar or change the dates. We will continue to provide the Board with updates as this process unfold.

#### 2021 GEORGIA ASSOCIATION OF VOTER REGISTRATION AND ELECTION OFFICIALS (GAVREO) CONFERENCE:

The 2022 conference is scheduled March 20, 2022 – March 23, 2022 and will be held in Athens, Georgia.

# **RENOVATION OF ELECTION CENTER/FORMER 911 BUNKER:**

There were renovations completed during this time period (September/October 2021) in the main office. Additionally, arrangements were made for the office to temporarily utilize (4) four office spaces on the second floor for storage as well as for our expanding office staff until November 30, 2021.

**UPDATE:** We moved out of this space by December 20, 2021 in order to allow Human Resources to occupy. We are currently awaiting Community Development's move out of our space in order to occupy. In order for Community Development to move renovations have to be completed to their building on Stephens Road. We will continue to provide updates to the Board.

# POLLING PLACE SURVEYS AND RESERVATIONS:

We are in the process of securing the reservations for the 2022 Polling Locations. If needed, we will provide recommendations to the Board for approval at upcoming Regular Scheduled Board meetings in preparation for future elections. We anticipate providing recommendations for new polling locations for the March 8, 2022 Regular Board meeting.

#### SECRETARY OF STATE ANNOUNCES NEW STATEWIDE VOTER REGISTRATION SYSTEM:

During the month of January, Secretary Raffensperger announced via press conference Secretary of State Elections Systems team has partnered with Sales Force and MTX to develop the new statewide voter registration system: Georgia Registered Voter Information System (GARViS). The launch date of GARViS is set for March 14, 2022. We will be attending a series of trainings associated with the new voter registration system in February.
