The following report represents a summary and recap of major operations and activities that we have completed or are ongoing within Elections and Registration for the month of September 2022 and activities since the last Board meeting.

The priorities were centered on Post-Election Day activities associated with the 2020 June Primary Elections November General & Special Post Election Day request as well as the January 5, 2021 Special and General Runoff Elections, processing voter registration applications, open record requests, the election activities for the Post – General elections, trainings, renovations, pre-election activities associated with the November 2022 election and the rearrangement of elections tasks due to the global pandemic COVID-19.

ELECTIONS

PERSONNEL STAFFING:

STAFFING PROFESSIONAL DEVELOPMENT AND TRAINING:

Deadline driven task from the redistribution of daily operations continue to receive priority training which included Staff Training.

2022 BOARD OF REGISTRATION AND ELECTIONS BOARD RETREAT:

The Clayton County Board of Registration and Elections Board retreat was held on Friday, September 23, 2022 from 9:00 AM – 4:00 PM at the Marriott AC Hotel Atlanta Airport Gateway.

2023 GEORGIA ASSOCIATION OF VOTER REGISTRATION AND ELECTION OFFICIALS (GAVREO) CONFERENCE:

The 2023 conference is scheduled February 12, 2023 – February 15, 2023 and will be held in Jekyll Island, Georgia. If you have not already, please inform our Administrative Assistant if you plan to attend.

RENOVATION OF ELECTION CENTER/FORMER 911 BUNKER:

Update as of late September, Director Hopkins has not provided the blueprint nor indicated in writing as requested the plan for renovations. However, Director Hopkins indicated that Information Technology will need additional space.

Per directive from Board Member Pullar, a timeline of all of the events associated with acquiring a building and renovations since 2016 was presented to the Board at the September Regular Board Meeting. We will continue to provide updates to the Board as this process unfolds.

<u>CERTIFICATION BOARD MEETINGS - NOVEMBER GENERAL & DECEMBER RUNOFF (IF NECESSARY)</u>:

The Regular and Special Called Board meeting for November has been combined and scheduled for Monday, November 14, 2022. The date for the December Regular and Special Called Board meeting has yet to be determined. The Board tabled this discussion at this time.

2022 NOVEMBER GENERAL ELECTION:

POLL WORKER TRAINING:

Poll Worker Training is set to start September 21, 2022 and will continue until October 29, 2022.

NOTE: We are seeking to recruit/retain 1,250 Poll Officials to serve. Currently we have 2,000 veteran and new Poll Officials confirmed to work and we are still receiving applications.

There are 50 classes scheduled to host our Poll Officials. Registration will open for scheduling on September 6, 2022. For those that are recruiting it is important that the applications are completed and returned to our office to ensure that the department reports accurately to Human Resources.

In order for a potential Poll Official to schedule training they are required to complete their paperwork with Human Resources and must be issued their county employee number prior to registering. These efforts ensure that all Poll Officials are prepared to receive payment for their services.

LOGIC AND ACCURACY TESTING:

Logic and Accuracy Testing is set to commence, Wednesday, September 17, 2022 and will continue until completion. We are at 80% completion.

EARLY/ADVANCE VOTING:

The dates in which a voter can vote in advance of Election Day are October 17, 2022 – November 4, 2022.

We are working with the Information Technology Department on a pilot program to post wait times at each Early Voting site for the upcoming election. More information to come.

EARLY ABSENTEE SCANNING:

Scanning will commence October 24, 2022. The following are dates/times in which the adjudication/duplication Teams will be needed:

- o Friday, November 11, 2022, 1:00 PM

These dates/times are subject to change. Should there be a need to adjust we will file and post the proper public notifications as required.

The Board will need to designate who will serve on the Vote Review Panel for the November General and December Runoff, if necessary at the upcoming Board meeting. 2022 DECEMBER GENERAL RUNOFF ELECTION:

2022 ELECTION YEAR ADVANCE VOTING DATES/TIME:

Director Dozier's recommendations below include expanding Early Voting locations across the county to (10) ten early voting locations to provide more access to our Clayton County Voters to vote in advance of Election Day. Should there be a need for a Runoff, a recommendation to customize early voting locations will be recommended and proposed to the Board of Elections and Registration.

UPDATE: Flint River Community Center and Sonna Singleton Gregory Senior Center will serve as an early voting location from Saturday, October 29, 2022 until November 4, 2022. Special thank you to Director Strawter-Tanks adjusting to accommodate elections. We are working together on planning out space in the facilities for the 2024 Presidential Election Year.
