The following report represents a summary and recap of major operations and activities that we have completed or are ongoing within Elections and Registration for the month of December 2022 and activities since the last Board meeting. The priorities were centered on Election Day activities associated with the November General processing voter registration applications, open record requests, trainings, renovations, audits; and December 6, 2022 Runoff Election.

ELECTIONS

PERSONNEL STAFFING:

STAFFING PROFESSIONAL DEVELOPMENT AND TRAINING:

Deadline driven task from the redistribution of daily operations continue to receive priority training which included Staff Training.

Those residents qualified to vote at said election shall be determined in all respects in accordance with election laws of the State of Georgia. This notice is given pursuant to action of the Clayton County Board of Elections and Registration. Director Dozier's recommendations below include expanding Early Voting locations across the county to (6) six (possibly (7) if we conduct the City of Jonesboro's Special Election) early voting locations to provide more access to our Clayton County Voters to vote in advance of Election Day.

Should there be a need for a Runoff, a recommendation to customize early voting locations will be recommended and proposed to the Board of Elections and Registration.
