The following report represents a summary and recap of major operations and activities that we have completed or are ongoing within Elections and Registration for the month of June 2023 and activities since the last Board meeting. The priorities were centered on Pre-Election Day activities associated with the 2023 November General Elections, processing voter registration applications, open record requests, trainings, performance evaluations and renovations.

ELECTIONS

PERSONNEL STAFFING:

STAFFING PROFESSIONAL DEVELOPMENT AND TRAINING:

Deadline driven task from the redistribution of daily operations continue to receive priority training which included Staff Training. Since the last Board meeting, the Office Team has undergone their performance evaluations and been submitted to Human Resources.

2024 GEORGIA ASSOCIATION OF VOTER REGISTRATION AND ELECTION OFFICIALS (GAVREO) CONFERENCE:

The conference will be held December 10, 2023 – December 13, 2023 in Athens, GA. Director Dozier serves as President and would like for all Board Members to attend the upcoming conference if available.

RENOVATION OF ELECTION CENTER/FORMER 911 BUNKER:

We met with Ben Hopkins, Director of Building and Maintenance on June 20, 2023. During our meeting a timeline of completion and space requirements discussion was held. Our anticipated move in date will be after the 2024 Presidential Election Year. More updates will be provided at a future meeting.

City of Lovejoy and Morrow were not able to attend but there have been discussions with both regarding the information shared. As a follow up, on June 29, 2023 we met with the municipalities in which we have entered into an IGA with to conduct their elections.

INTERGOVERMENAL AGREEMENTS (IGA) 2023 NOVEMBER GENERAL ELECTION:

The Board of Commissioners approved the following IGAs for the county to conduct their 2023 municipal elections: City of College Park, City of Lake City and City of Jonesboro. NOTE: The City of Morrow's IGA has already been established.

The City of Forest Park is now interested in the county conducting their 2023 November General Municipal Election instead of the already established IGA to use the voting equipment. Ricky Clark of the City of Forest Park informed the county on June 28, 2023. We will be providing you another IGA for consideration.

PRECINCT BOUNDARY LINE CHANGES: PROPOSAL 03/2023 - 15/2023:

We will be presenting 12 precinct boundary line changes to adjust municipal lines to match precinct boundary lines at the upcoming meeting. All impacted voters will receive a new precinct card upon Board's approval.

MUNICIPAL STREET AUDIT:

In order to assure that we provide the municipalities in Clayton County an accurate voter's list by their August candidate qualifying, we have provided each with their street list to review and provide us any changes. The deadline of return is July 14, 2023.
