RESOLUTION NO. 2023-6

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPLY FOR AND ACCEPT A GRANT FROM THE CRIMINAL JUSTICE COORDINATING COUNCIL GRANT, COMMUNITY POLICING MICROGRANT, PROJECT SAFE NEIGHBORHOOD TO ALLOW THE CLAYTON COUNTY POLICE DEPARTMENT TO STRENGTHEN PUBLIC SAFETY RELATIONSHIPS BETWEEN PUBLIC SAFETY AND CITIZENS; TO AUTHORIZE THE CHAIRMAN TO ACCEPT THE DONATION ON BEHALF OF THE COUNTY AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Criminal Justice Coordinating Council Grant # PSN-P20-8-005, the Community Policing Microgrant, and Project Safe Neighborhood (Fiscal Year 2020/2021) wish to grant \$15,000 to the Clayton County Police Department (the "Department"); and

WHEREAS, this is a non-matching grant to allow the Clayton County Police Department to create more opportunities and flexibility for the community to participate to assist with leveraging police legitimacy; and

WHEREAS, this grant will provide funding to educate, inform and empower the public about the County's Neighborhood Watch (NHW) programs; and

WHEREAS, the NHW programs will address police legitimacy, improve trust between the community and police, and empower communities to deter crime through strengthened public safety relationships; and

WHEREAS, the donation does not require a match of funds from Clayton County and there is no financial impact to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served by the acceptance of the donation for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept a grant of up to \$15,000.00 from the Criminal Justice Coordinating Council Grant # PSN-P20-8-005, Community Policing Microgrant, FY2020/2021 Project Safe Neighborhood (PSN) on behalf of the Clayton County Police Department to educate, inform and empower the public about the County's Neighborhood Watch programs.

Section 2. The Board of Commissioners authorizes the Chairman to accept the donation on behalf of Clayton County and to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners further authorizes the Chief Financial Officer to amend the budget to reflect an appropriate revenue source and expense as may be required by the terms of the grant.


Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
