RESOLUTION NO. 2023-84

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO GRANT A SPECIAL FACILITY USE REQUEST TO ALLOW THE ROTARY CLUB OF ATLANTA SOUTHERN CRESCENT TO HOST A DUCK DERBY FUNDRAISER IN A PORTION OF THE SPIVEY SPLASH LAZY RIVER AREA TO SUPPORT COMMUNITY SERVICE PROJECTS; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, a Special Facility Use Request (the “Request”) was received from the Rotary Club of Atlanta Southern Crescent (the “Promoter”) for use of a portion of the Spivey Splash Lazy River (the “Facility”) for the purpose of hosting a Duck Derby, a fundraiser where rubber ducks are sold and floated down a portion of the lazy river, (the “Event”) for the public on Saturday, September 9, 2023; and

WHEREAS, the Promoter would like to use the Facility from 10:00 A.M. to 2:00 P.M.; and

WHEREAS, the public will be charged an entry fee offsite as part of the fundraiser; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Facility and allowing the Promoter to facilitate this Event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to grant a Special Facility Use Request to the Rotary Club of Atlanta Southern Crescent to use a

portion of the Spivey Splash Lazy River area for the Duck Derby fundraiser. The Event will take place on Saturday, September 9, 2023, from 10:00 A.M. to 2:00 P.M.

Section 2. The Board of Commissioners authorizes the County to grant this Special Facility Request to the Rotary Club of Atlanta Southern Crescent free of charge. The Board further authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by Clayton County Risk Management.
