RESOLUTION NO. 2023-171

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA TO SUPPORT “FOREST PARK DAY 2023” HOSTED BY FOREST PARK COUNCILWOMAN LATRESA AKINS-WELLS IN PARTNERSHIP WITH COMMISSIONER ALIEKA ANDERSON; TO ENTER INTO AND EXECUTE AN AGREEMENT IN SUPPORT OF SAME; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the City of Forest Park, Georgia (“the City”) is a municipality located in Clayton County (“the County”); and

WHEREAS, the City is hosting “Forest Park Day 2023” (“the Event”) on August 19, 2023 at Starr Park located at 5031 Park Avenue, Forest Park, Georgia 30297; and

WHEREAS, the Event is intended to bring out hundreds of families, residents and visitors for music, recreational activities, live entertainment and food; and

WHEREAS, the City is marketing the Event under the tagline “We Are #OneForestPark;” and

WHEREAS, the Event is being hosted by Forest Park Councilwoman Latresa Akins-Wells (“Councilwoman Akins-Wells”); and

WHEREAS, the City has solicited sponsorships supporting the Event; and

WHEREAS, the County also markets itself with a tagline “#Claytonconnected;”
and

WHEREAS, the Board of Commissioners finds that supporting events within the County fosters a sense of community within the unincorporated and incorporated jurisdictions of the County; and

WHEREAS, Commissioner Alieka Anderson desires to partner with Councilwoman Akins-Wells in support of the Event; and

WHEREAS, the Board of Commissioners desires for the County to be a sponsor for the Event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by supporting the Event.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Clayton County Board of Commissioners hereby supports the City of Forest Park’s “Forest Park Day 2023” hosted by Forest Park Councilwoman Latresa Akins-Wells in partnership with Commissioner Alieka Anderson which will take place on Saturday, August 19, 2023 from 12pm until 9pm at Starr Park located at 5031 Park Avenue, Forest Park, GA 30297. The Board authorizes the County to enter into an Agreement authorizing an expenditure up to \$8,000 as a sponsor. The Board of Commissioners authorizes the Chairman to execute the Agreement and to perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners further authorizes the Chief Financial Officer to amend the budget to reflect an appropriate revenue source and expense as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
