RESOLUTION NO. 2023- 158

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH THE CLAYTON COUNTY COLLABORATIVE AUTHORITY, TO APPLY FOR, AND IF AWARDED, ACCEPT FUNDING FROM THE GEORGIA OF HUMAN SERVICES FOR THE CLAYTON COUNTY FAMILY CONNECTION COLLABORATIVE PLAN; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE THE GRANT AGREEMENT AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County (“County”), through the Clayton County Collaborative Authority, wishes to apply for, and if awarded, accept, the Georgia Department of Human Services (“GDHS”) Family Connection Grant (“Grant”) funding for program services to be used in connection with the Clayton County Family Connection Collaborative Plan; and

WHEREAS, the County is applying for Grant funds in the amount of \$52,500.00, requiring no match from the County; and

WHEREAS, the effective dates of this Grant funds are July 1, 2023, through June 30, 2024; and

WHEREAS, GDHS and the County desire, through the Clayton County Family Connection Collaborative Plan, to improve the lives of the County's children and families

through community-based collaboration and planning by the provision of services in a more focused family-centered environment which positively impacts child health, child development, academic achievement, family functioning and economic capacity; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the agreement with the Georgia Department of Human Services for the stated purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to apply for, and if awarded, accept the Georgia Department of Human Services' Family Connection Grant funds in the amount of \$52,500.00, with no matching requirement from Clayton County, to be used for the Clayton County Family Connection Collaborative Plan. The agreement shall be in substantially the form as attached hereto as Exhibit A subject to any minor modifications or amendments as may be required by the Chairman or the Chief Staff Attorney. The Board of Commissioners authorizes the Chairman to execute the agreement, and otherwise to perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.
