## RESOLUTION NO. 2024-101

A RESOLUTION AUTHORIZING CLAYTON COUNTY THROUGH THE CLAYTON COUNTY CENTRAL SERVICES DEPARTMENT TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH EGGROLL BOYZ FOR PUBLIC EVENTS HELD IN CLAYTON COUNTY, GEORGIA; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County ("County"), through the Clayton County Central Services Department, wishes to enter into a Memorandum of Understanding ("MOU") (Exhibit A) with Eggroll Boyz ("Vendor"), a food truck vendor, which will provide food items and/or beverages for purchase to patrons during public events held in Clayton County, Georgia; and

WHEREAS, the purpose of the proposed MOU is to establish the terms and conditions under which the Vendor will be allowed to provide food items and/or beverages to patrons during public events held in Clayton County, Georgia; and

WHEREAS, the Vendor shall fulfill all duties and responsibilities as well as insurance, license, and permit requirements as set forth in the MOU, including accepting food vouchers from Clayton County employees if the event allows employees to use said vouchers to purchase food items and beverages;

WHEREAS, after services have been rendered by the Vendor, the County will reimburse the Vendor within twenty-one (21) business days for any food vouchers received from Clayton County employees during the event;

WHEREAS, the MOU is effective upon the day and date last signed and executed by the duly authorized representatives of the County and Vendor; and

WHEREAS, the initial term of Contract between the County and the Vendor shall be for one (1) year and may be automatically renewed for two (2) successive one (1) year terms upon the same terms and conditions; and

WHEREAS, the services to be performed under this MOU shall commence on the effective date of the MOU and terminate absolutely and without further obligation on the part of the County on December 31<sup>st</sup> of the year in which it was executed and on December 31<sup>st</sup> of each succeeding and renewed year, as required by O.C.G.A. § 36-60-13, as amended, unless terminated earlier in accordance with the termination provision of the MOU; and

WHEREAS, the MOU may be terminated, with or without cause, by either party upon thirty (30) days written notice;

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the Memorandum of Understanding with Eggroll Boyz to provide food items and/or beverages to patrons during public events held in Clayton County, Georgia.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, through the Clayton County Central Services Department, to enter into a Memorandum of Understanding ("MOU") with Eggroll Boyz, a food truck vendor, to provide food items and/or beverages for purchase to patrons at public events held in Clayton County, Georgia. The MOU shall be in substantially the same form attached hereto as "Exhibit A," subject to

such minor changes, insertions, or deletions as the County Attorney and/or Chairman of the Board of Commissioners may approve. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto. The Board of Commissioners further authorizes the Chairman, or his designee, to execute the MOUs, with such minor changes, insertions, or deletions, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.

<u>Section 2</u>. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
