RESOLUTION NO. 2024-232

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ESTABLISH HOURS OF OPERATIONS FOR CLAYTON COUNTY LIBRARY SYSTEM, CLAYTON COUNTY DEPARTMENT OF PARKS AND RECREATION, AND SENIOR SERVICES FACILITIES DURING THE THANKSGIVING, CHRISTMAS, AND NEW YEAR HOLIDAYS; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Library System, Clayton County Department of Parks and Recreation, and Senior Services are requesting the Board of Commissioners to adopt the following proposed holiday schedule for their respective facilities during the November 2024-January 2025 holiday season; and

WHEREAS, the Board deems it in the best interest of the County and the County will be best served by establishing the following holiday hours of operation for these facilities.

Monday, December 2nd – Regular Hours

December Special Hours

Monday, December 23rd – Closed
Tuesday, December 24th – Closed (Christmas Holiday)
Wednesday, December 25th – Closed (Christmas Holiday)
Thursday, December 26th – Regular Hours
Tuesday, December 31st – 8:00 a.m.-5:00 p.m.

January Special Hours

Wednesday, January 1st – Closed (New Year's Day)
Thursday, January 2nd – Regular Hours
