A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH THE PARKS AND RECREATION DEPARTMENT, TO GRANT A SPECIAL FACILITY USE REQUEST TO CLAYTON STATE UNIVERSITY CLUB FOOTBALL TO UTILIZE SPACE WITHIN MORROW LAKE CITY PARK / FIELD 1 TO CONDUCT PRACTICES FOR THE 2024 SEASON; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, ~~WHEREAS,~~ a Special Facility Use Request (the "Request") was received from the Clayton State University Club Football, a nonprofit organization, for the use of space within Morrow Lake City Park/Field 1 (the "Facility") for the purpose of holding practices (the "Event") from August through November 2024, daily on Mondays through Fridays from 3:00pm to 6:00pm; and

WHEREAS, the Clayton State University Club Football would request access to restrooms and will be responsible for their equipment; and

WHEREAS, due to the nature of the organization being not for profit and for the benefit of Clayton State University Club Football members, they request that any facility use charges be waived; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Facility and allowing the Clayton State University Club Football to facilitate this Event at no cost.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to grant a Special Facility Use Request to the Clayton State University Club Football to utilize space within Morrow Lake City Park / Field 1 to conduct practices for the 2024 season.

Section 2. The Board of Commissioners authorizes the County to grant this Special Facility Request to the Clayton State University Club Football free of charge. The Board further authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by Clayton County Risk Management.
