RESOLUTION NO. 2025-25

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH CLAYTON COUNTY LIBRARY SYSTEM, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH HEART HEALTHY HABITS, INC. TO PROVIDE INFORMATION AND TRAINING TO CLAYTON COUNTY RESIDENTS ON HEALTHY LIVING PRACTICES AND LIFE-SAVING CARDIOPULMONARY RESUSCITATION TECHNIQUES; TO AUTHORIZE THE CHAIRWOMAN OR HER DESIGNEE TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE AS NECESSARY; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Library System (the "Library") wishes to enter into a Memorandum of Understanding ("MOU") with Heart Healthy Habits, Inc. to provide information and training on healthy living practices and life-saving Cardiopulmonary Resuscitation ("CPR") techniques; and

WHEREAS, the MOU between the parties sets forth the anticipated roles, responsibilities, and joint activities between the Library and Heart Healthy Habits, Inc. for a Heart Initiative Program; and

WHEREAS, Heart Healthy Habits, Inc. will sponsor workshops at no charge to the public to educate participants on nutrition, exercise, stress management, and CPR techniques, including Automated External Defibrillator (“AED”) training; and

WHEREAS, the workshop will be held twice a year in May 2025 and November 2025 at the Library’s Northwest Branch for a minimum of three (3) hours depending on the number of participants; and

WHEREAS, Heart Healthy Habits, Inc. will provide all materials such as Mannequins and AED machines for the workshop at no cost to the Library; and

WHEREAS, the Library will provide the space and audiovisual equipment for the workshops;

WHEREAS, there is no financial impact on the County as Heart Healthy Habits, Inc. will provide all the materials for the workshops at no cost to the County; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into an MOU with Heart Healthy Habits, Inc. to provide information and training to Clayton County residents on healthy living practices and life-saving CPR techniques.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED:

Section 1. The Board of Commissioners authorizes Clayton County, through the Clayton County Library System, to enter into a Memorandum of Understanding with Heart Healthy Habits, Inc. to provide information and training to Clayton County residents on healthy living practices and life-saving Cardiopulmonary Resuscitation techniques. The Memorandum of Understanding shall be in substantially the form as attached hereto as Exhibit A subject to any necessary minor revisions as the Chief Staff Attorney or


Chairwoman may prescribe. The Board also authorizes the Chairwoman or her designee to execute the Memorandum of Understanding and otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners further authorizes the Chief Financial Officer to amend the budget to reflect an appropriate revenue source and expense as necessary.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


