RESOLUTION NO. 2025-26

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH ITS OFFICE OF RESILIENCE AND SUSTAINABILITY, TO ENTER INTO AN INTERAGENCY ACQUISITION AGREEMENT WITH CLAYTON COUNTY PUBLIC SCHOOLS TO DONATE NALOXONE KITS AND DOSES OF NALOXONE TO CLAYTON COUNTY PUBLIC SCHOOLS; TO AUTHORIZE THE CHAIRWOMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Office of Resiliency and Sustainability (“ORS”), through its Emergency Management division, plays a central role in the county’s overall emergency planning, preparedness, response, and recovery efforts to support public health and safety; and

WHEREAS, ORS has purchased 100 Naloxone kits and 300 doses of Naloxone with the remainder of funds from the American Rescue Plan Act (“ARPA”); and

WHEREAS, ORS seeks to enter into an interagency acquisition agreement with Clayton County Public Schools (“CCPS”) to donate 100 Naloxone kits and 300 doses of Naloxone to CCPS to assist CCPS in its compliance with State law; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by establishing an interagency acquisition agreement between ORS and CCPS for the stated purposes.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the Clayton County Office of Resilience and Sustainability to enter into an Interagency Acquisition Agreement with Clayton County Public Schools to donate 100 Naloxone kits and 300 doses of Naloxone to Clayton County Public Schools. The Board also authorizes the Chairwoman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
