RESOLUTION NO. 2025-28

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY SENIOR SERVICES DEPARTMENT, TO GRANT A SPECIAL FACILITY USE REQUEST TO THE VILLAGES OF ELLENWOOD SUBDIVISION FOR A HOMEOWNERS' ASSOCIATION MEETING; TO AUTHORIZE THE CHAIRWOMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, a Special Facility Use Request (the "Request") was received from the Villages of Ellenwood Homeowners' Association for use of the Sonna Singleton Gregory Senior Center (the "Senior Center") for the purpose of hosting a Homeowners' Association ("HOA") meeting (the "Event"); and

WHEREAS, a meeting room in the Senior Center will be utilized between the hours of 5:30 p.m. to 7:30 p.m. on March 24, 2025; and

WHEREAS, the anticipated number of people attending the Event is 30; and

WHEREAS, the County will not collect the fee of \$300.00 in revenue for use of the meeting room at the Senior Center at the request of the Villages of Ellenwood HOA; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Senior Center for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to grant a Special Facility Use Request to the Villages of Ellenwood Subdivision to host a Homeowners' Association ("HOA") meeting at Sonna Singleton Gregory Senior Center on March 24, 2025 between the hours of 5:30 p.m. to 7:30 p.m. at no cost to the HOA. The Board further authorizes the Chairwoman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Agreement.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by the Clayton County Risk Management Department.
