RESOLUTION NO. 2009 - 173

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE GEORGIA DEPARTMENT OF REVENUE UNDER WHICH CLAYTON COUNTY WILL OBTAIN MOTOR VEHICLE REGISTRATION INFORMATION FOR THE ISSUANCE OF TICKETS UNDER THE AUTOMATED RED LIGHT CAMERA PROGRAM; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; ALL AS MAY BE REQUIRED IN THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Georgia Department of Revenue (hereinafter "Department") is responsible for the issuance of motor vehicle registrations and the maintenance of registration records; and

WHEREAS, the Department has created an electronic process by which it may obtain motor vehicle registration record information; and

WHEREAS, the Commissioner of the Department is authorized to release registration records to any appropriate government official, entity, or agency for the purpose of carrying out official government functions or legitimate governmental duties; and

WHEREAS, Clayton County desires to obtain motor vehicle registration records from the Department for use in connection with the processing, issuance and collection of fines for tickets issued under the red light camera program; and

WHEREAS, the Board of Commissioners deems the agreement to be in the best interest of Clayton County and the County will best be served by entering into the Agreement with the Department, for the above named purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF
COMMISSIONERS OF CLAYTON COUNTY, GEORGIA
AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Eldrin Bell, Chairman of the Board of Commissioners, to enter into an Intergovernmental Agreement with the Georgia Department of Revenue to obtain motor vehicle registration information for the issuance citations under the red light camera program. The Board of Commissioners also authorizes the Chairman to otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the agreement.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


