RESOLUTION NO. 2011 - 38

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW LEADERSHIP AND DEVELOPMENT OF OUR YOUTH IN SPORTS, INC. TO SPONSOR AND HOST ITS NINTH ANNUAL GIRLS BASKETBALL TOURNAMENT AT THE CARL RHODENIZER RECREATION CENTER AND THE VIRGINIA BURTON GRAY RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, Leadership and Development of our Youth in Sports, Inc. d/b/a LADYS, Inc. (the "Promoter") desires to sponsor and host on April 29 and 30, 2011, the Ninth Girls Basketball Tournament (the "Event") at the Carl Rhodenizer Recreation Center and, tentatively, at the Virginia Burton Gray Recreation Center, both in Clayton County, Georgia; and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing the Event, with no capital expense to Clayton County, and where funds raised from the Event will provide financial assistance for players in need, traveling expenses for elite teams, and where a percentage of the proceeds will benefit the Kay Yow Breast Cancer Fund; and

WHEREAS, the Promoter is qualified to organize, promote and manage the Event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to sponsor and host the Event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to allow Leadership and Development of our Youth in Sports, Inc. d/b/a LADYS, Inc. to sponsor and host on April 29

and 30, 2011, the Ninth Girls Basketball Tournament at the Carl Rhodenizer Recreation Center and, tentatively, at the Virginia Burton Gray Recreation Center.

Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.


