RESOLUTION NO. 2011 - 46

A RESOLUTION APPROVING CLAYTON COUNTY'S SUBMITTAL OF MULTIPLE PROJECTS TO THE ATLANTA REGIONAL COMMISSION FOR POTENTIAL INCLUSION ON THE PROJECT LIST THAT WILL BE VOTED ON IN THE NOVEMBER 2012 PRIMARY ELECTION AS PROVIDED FOR IN HOUSE BILL 277, THE TRANSPORTATION INVESTMENT ACT OF 2010; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO SUBMIT THE LIST, AND OTHERWISE TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, House Bill 277, known as the Transportation Investment Act of 2010 was passed into law in June 2010, putting future transportation projects in the hands of voters; and

WHEREAS, the Act provides that elected officials in each of the 12 regions will develop a list of projects to be funded by a one percent sales tax, and further requires each of the regions to have a roundtable of elected officials that will develop a project list that will be available to voters before they go to the polls; and

WHEREAS, over the past month, coordination meetings have been held amongst representatives of the seven municipalities in the county and the County, for the purpose of developing a list of projects that provide significant benefits to our region, meet the criteria for inclusion as established by the process set up by the Act and is required to be submitted by March 30, 2011; and

WHEREAS, the list of projects is attached hereto as Exhibit "A"; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by approving the list of projects to be submitted to the Atlanta Regional Commission for the above-stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby approves and authorizes Clayton County to submit the list of multiple projects as set forth in the attached Exhibit "A", to the Atlanta Regional Commission in

accordance with House Bill 277 the Transportation Investment Act of 2010. Further, the Board of Commissioners hereby authorizes the Chairman or his designee to submit the project list, and otherwise to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.



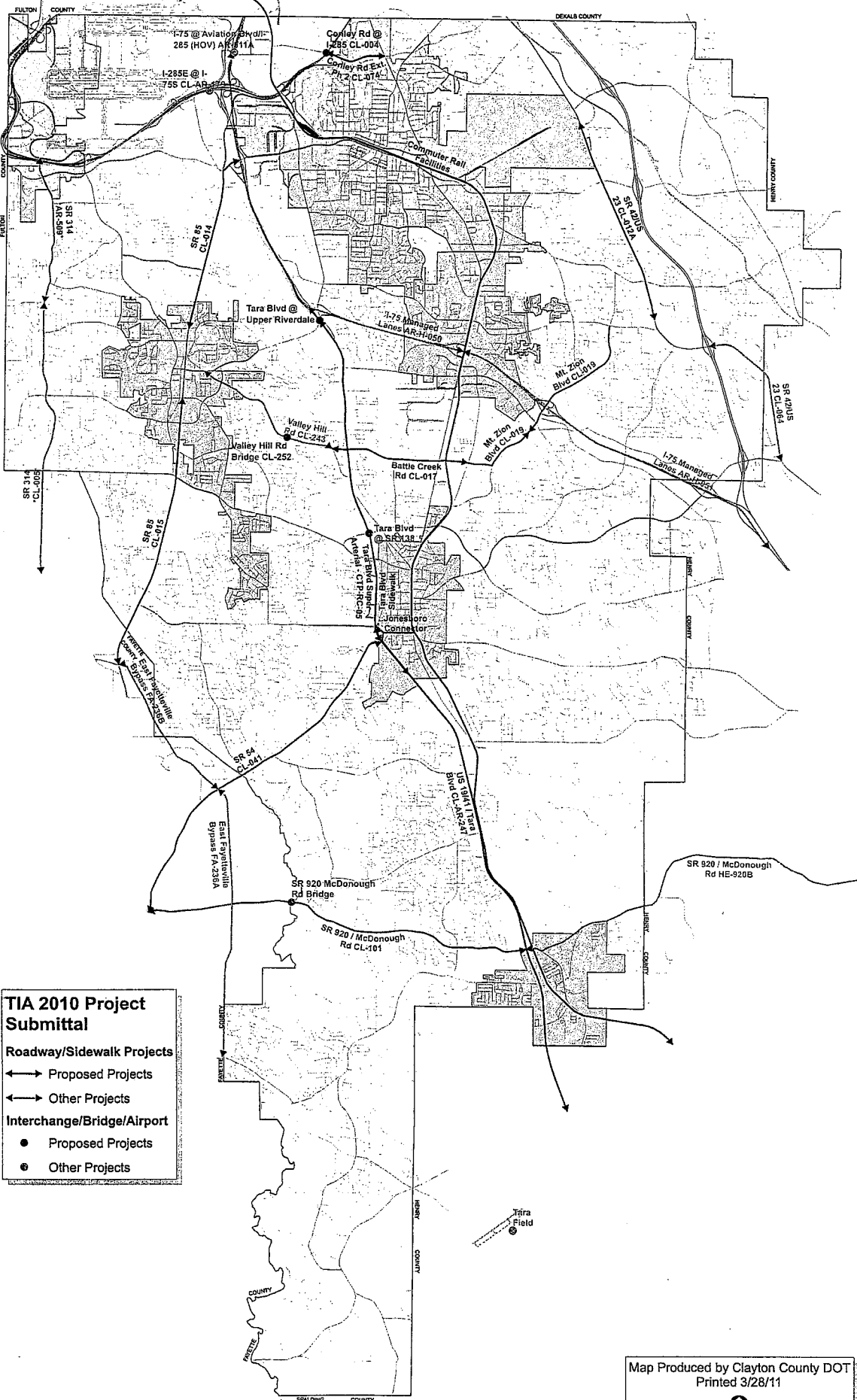
