RESOLUTION NO. 2011 - 145

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH THE PARKS AND RECREATION DEPARTMENT, TO ACCEPT \$13,000.00 IN GRANT FUNDS FROM THE CLAYTON COUNTY BOARD OF HEALTH TO DEVELOP A QUALITY TEEN PREGNANCY PREVENTION PROGRAM FOR YOUTHS IN CLAYTON COUNTY; TO AUTHORIZE THE CHAIRMAN AND THE DIRECTOR OF THE PARKS AND RECREATION DEPARTMENT TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Board of Health selected the Parks and Recreation Department to be designated as a TOP Club site and receive a \$13,000.00 grant for the 2011-2012 program year of its Teen Pregnancy Prevention Program; and

WHEREAS, the grant funds will help support expenses related to the development and implementation of the Teen Pregnancy Prevention Program, i.e. facility costs, program supplies, transportation, nutritious snacks and meals, posters, banners and give-aways for the teen participants, and support staff working in the Program; and

WHEREAS, the Program will be facilitated at the Jim Huie/Steve Lundquist Recreation Center (the "Facility") one day a week for 12 weeks, and will consist of a minimum of 25 teenagers, age 11 through 17; and

WHEREAS, there is no impact on the Facility with the implementation of this Program; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by accepting the grant funds for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, through its Parks and Recreation Department, to accept \$13,000.00 in grant funds from the Clayton County Board Health for implementation of the Teen Pregnancy Prevention Program; to authorize the Chairman and the Director of the Parks and Recreation Department to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, if any.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


