RESOLUTION NO. 2013 – 114

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A SPONSOR/SITE AGREEMENT WITH BRIGHT FROM THE START PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE UNITED STATES DEPARTMENT OF AGRICULTURE’S SUMMER FOOD SERVICE PROGRAM WILL BE ADMINISTERED THROUGH THE SENIOR SERVICES DEPARTMENT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Senior Services Department has previously participated in the United States Department of Agriculture’s (USDA) Summer Food Service Program under various sponsors; and

WHEREAS, sponsorship for the Program, which is administered by Bright From The Start (the “Provider”), is currently available through Girls First, Inc., of Stockbridge, GA (the “Sponsor”); and

WHEREAS, the Program will be in operation from June 3, 2013, through August 2, 2013, to serve free lunch to all Kinship Program Summer Camp participants at the Shelnett Inter-Generational Center; and

WHEREAS, a designated Site Supervisor will be trained on the rules and facilitation of meals by the Sponsor; and

WHEREAS, there is no budgetary impact on the County in connection with the Program; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the Sponsor/Site Agreement with the Provider for the stated purpose.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Sponsor/Site Agreement with Bright From The Start, providing for the terms and conditions under which the Senior Services Department will participate in the United States Department of Agriculture's Summer Food Service Program under the sponsorship of Girls First, Inc., of Stockbridge. The Board of Commissioners hereby authorizes the Chairman to execute the Agreement and otherwise to perform all other acts necessary to accomplish the intent of this Resolution. The Agreement shall be in the form attached hereto, subject to such minor changes, insertions or deletions as the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


