RESOLUTION NO. 2013-250

A RESOLUTION AUTHORIZING THE TRADE OR OTHER DISPOSITION OF CONDEMNED VEHICLES FROM THE CLAYTON COUNTY SHERIFF'S OFFICE; TO AUTHORIZE THE DIRECTOR OF CENTRAL SERVICES TO EFFECT THE DISPOSITION OF SAID VEHICLES AS SURPLUS ITEMS; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO AUTHORIZE THE DISBURSEMENT OF PROCEEDS FROM THE TRADE OF SUCH PROPERTY; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Sheriff's Office previously seized a 2007 Mercedes Benz (VIN: WDDDJ77X67A101208) and a 2009 Chevrolet Corvette ZR1 (VIN: 1G1YR26R695800093) during a drug investigation; and

WHEREAS, the Clayton County Sheriff's Office did assist with the drug investigation by possessing and storing the seized vehicles as they awaited forfeiture; and

WHEREAS, the Director of Fleet Maintenance previously evaluated and determined said vehicles were suitable for service as County vehicles and used in conjunction with some of the school programs in which the Sheriff's Office was formerly involved; and

WHEREAS, the vehicles have proven to be impractical, costly to maintain and now serve no practical purpose in the Sheriff's Office; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by authorizing the Director of Central Services to affect the trade of these vehicles to Terry Cullen Southlake Chevrolet ("Terry Cullen") pursuant to the offers as evidenced in Exhibit A attached hereto; and

WHEREAS, the Board also authorizes the Director of Central Services to use the proceeds from said trade to acquire a 2013 Chevrolet Tahoe and a 2013 Chevrolet Camaro from Terry Cullen pursuant to the offers as evidenced in Exhibit B attached hereto.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the Director of Central Services to effect the trade of the 2007 Mercedes Benz (VIN: WDDDJ77X67A101208) and 2009 Chevrolet Corvette ZR1 (VIN: 1G1YR26R695800093) to Terry Cullen Southlake Chevrolet. The trade shall be conducted in a manner as will be in the best interest of the County, and in accordance with provisions of Section 2-146 of the Clayton County Code of Ordinances. The proceeds of the trade of these vehicles shall be used to purchase a 2013 Chevrolet Tahoe and a 2013 Chevrolet Camaro from Terry Cullen. The Director of Central Services and Chief Financial Officer are authorized to perform all acts necessary to accomplish the intent of this Resolution.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
