RESOLUTION NO. 2014-133

RESOLVED, A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT TO ALLOW HELP FOUNDATION INC. TO SPONSOR AND HOST THE "SO YOU THINK YOU CAN COOK" EVENT AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Help Foundation Inc., d/b/a Talknnn Turkey Restaurant (the "Promoter"), desires to sponsor and host the "So You Think You Can Cook" event on August 16, 2014 at the Multi-Purpose Field at Clayton County International Park; and

WHEREAS, the event is a fundraiser for cancer and Alzheimer's disease research, and will include prizes, local celebrity judges, booth rentals and sponsors; and

WHEREAS, the Promoter has the responsibility of hosting, organizing, promoting and managing the event, with no capital expense to Clayton County; and

WHEREAS, the Director of the Parks and Recreation Department (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's recommended Special Event Fee of \$350.00, a Coordinator fee of \$150.00 for safety and organization purposes (\$10.00 per hour for 15), a Maintenance Fee of \$240.00 (\$10 per hour for 12 hours multiplied by two employees), and a Security Officer for \$405.00 (\$45.00 per hour for nine hours), for a total of \$1,145.00 for the event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to sponsor and host this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement to allow Help Foundation Inc. to sponsor and host the “So You Think You Can Cook” event on August 16, 2014 at the Multi-Purpose Field at Clayton County International Park. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment “A” and otherwise perform all other acts necessary to accomplish the intent of this Resolution.


Section 2. The Board of Commissioners approves the Special Event Fee of \$350.00, a Coordinator fee of \$150.00, a Maintenance Fee of \$240.00 and a Security Officer for \$405.00 to be paid by the Promoter for the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.


