RESOLUTION NO. 2014 - 188

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH WE NEED 2 READ, INC. PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH THE "FOOD TRUCKS @ THE BEACH" EVENT WILL BE HOSTED AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, We Need 2 Read, Inc. (the "Promoter") wishes to utilize the Beach area, Beach pavilions, Upper Field and other specified areas at Clayton County International Park (the "Location") to host an event titled, "Food Trucks @ the Beach", consisting of a beach party, car and motorcycle show, barbecue contest, concessions, live musical entertainment, and amplified music, and where the County is solely responsible for providing personnel for facility maintenance, safety and program coordination; and

WHEREAS, the Promoter wishes to utilize the Location in Jonesboro, Georgia on September 14, 2014 from approximately 10:00 A.M. until 8:00 P.M., with the purposes of generating funds to provide scholarships to metro-County schools and providing citizens a place to be entertained in a family-friendly atmosphere; and

WHEREAS, the Director of the Parks and Recreation Department recommends that the Promoter pay the half price, non-profit rates for the Special Event Fee (\$1,250.00 for the Beach area, Beach pavilions and Upper Field) and Pavilion Rental Fees (\$150.00 each for the St. Vincent, St. Barts and Bermuda pavilions and \$300.00 for St. Thomas Pavilion), and will pay for the services of five Event Maintenance Employees (\$10 per

hour for twelve hours each—\$600.00), twenty-three Lifeguards (\$10.00 per hour for eight hours each—\$1,840.00), one Park Coordinator for safety and security purposes (\$10.00 per hour for fourteen hours—\$1400.00), five County Police Officers (\$45.00 per hour for fourteen hours each—\$3,150.00), and a \$300.00 Deposit Fee for the event, for a total of \$8,030.00; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement with We Need 2 Read, Inc. (the “Promoter”) providing for hosting an event titled, “Food Trucks @ the Beach” to be held on September 14, 2014 at the Clayton County International Park for the purposes of generating funds to provide scholarships to metro-County schools and providing citizens a place to be entertained in a family-friendly atmosphere. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.




