RESOLUTION NO. 2015 -229

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF A SEIZED VEHICLE TO BE ASSIGNED TO THE CLAYTON COUNTY SHERIFF'S OFFICE FLEET IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO AUTHORIZE THE DIRECTORS OF CENTRAL SERVICES, AND FLEET MAINTENANCE TO PERFORM ALL ACTS REQUIRED BY THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, U.S. Customs and Border Protection ("U.S. Customs") seized a 2005 Nissan Altima, (VIN) 1N4BL11D25N480856 during a joint drug investigation with the Clayton County Sheriff's Office; and

WHEREAS, U.S. Customs has transferred title of the seized vehicle to the Clayton County Sheriff's Office; and

WHEREAS, Fleet Maintenance has determined said vehicle is in good condition and has recommended the unit for service as a County vehicle, and to replace a vehicle that was recently determined to be no longer suitable for service as a County vehicle; and

WHEREAS, the vehicle will be used in drug and fugitive operations;

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting said vehicle and assigning it to the Sheriff's Office Fleet in accordance with applicable County Ordinances.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept title to a 2005 Nissan Altima, (VIN) 1N4BL11D25N480856 seized by U.S.

Customs and Border Protection during a joint drug investigation with the Clayton County Sheriff's Office, and to assign said vehicle to the Clayton County Sheriff's Office vehicle fleet for the purpose of enhancing law enforcement in accordance with state and federal statutes. The Board of Commissioners authorizes the Directors of Central Service, and Fleet Maintenance to perform all acts necessary to effect this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




