RESOLUTION NO. 2015-88

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO SUBMIT A GRANT APPLICATION TO THE DEPARTMENT OF FAMILY AND CHILDREN SERVICES ON BEHALF OF CLAYTON COUNTY SENIOR SERVICES, TO PROVIDE FUNDING FOR PARENTING EDUCATION; TO AUTHORIZE THE CHAIRMAN TO EXECUTE NECESSARY DOCUMENTS ON BEHALF OF THE COUNTY AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County desires to provide parenting education to its citizens; and

WHEREAS, the County wishes to apply for, and if awarded, accept Grant funds from the Department of Family and Children Services in the amount of \$75,000 to further these efforts; and

WHEREAS, a match of local funds in the amount of \$25,000 is required which can be contributed in the form of staff salaries; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by applying for, and if awarded, accepting Grant funds to facilitate Parenting Education.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes the County to apply for, and if awarded, accept Grant funds from the Department of Family and Children Services for Parenting Education. The Board authorizes the Chairman to execute all necessary documents on behalf of the County and to perform all other acts necessary to accomplish the intent of this

Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


