RESOLUTION NO. 2019 – 140

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPLY FOR AND ACCEPT A GRANT FROM STATE OF GEORGIA EMERGENCY MANAGEMENT AND HOMELAND SECURITY AGENCY FOR THE CLAYTON COUNTY FIRE AND EMERGENCY SERVICES' SEARCH AND RESCUE TEAM; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE ANY AGREEMENT(S) AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, as part of Clayton County, Georgia's Search and Rescue team ("the County"), its Fire and Emergency Services relies on annual grant funding to ensure its capabilities remain in place and are aligned with the other teams across the State of Georgia; and

WHEREAS, the County, through its Fire and Emergency Services department, desires to apply for and accept grant funding on behalf of the FY2019 Homeland Security Grant Program in the amount of \$25,847.00 to further enhance the abilities of the Georgia Search and Rescue team assigned to Clayton County Fire & Emergency Services; and

WHEREAS, the County deems it in the best interest of Clayton County and its citizens, and the County and its citizens will best be served by applying for and accepting these grant funds to ensure its capabilities remain in place to carry out the purposes of the Search and Rescue team.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, through its Fire and Emergency Services department, to apply for and accept grant funds from Georgia Emergency Management and Homeland Security Agency in an amount up to \$25,847.00 to enhance the abilities of the Georgia Search and Rescue team assigned to Clayton County Fire & Emergency Services. The Board authorizes the Chairman or his designee to execute any Agreement(s) and to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
