RESOLUTION NO. 2020-7

A RESOLUTION TO READOPT THE CLAYTON COUNTY EMERGENCY OPERATIONS PLAN; TO AUTHORIZE THE CHAIRMAN TO PERFORM ANY ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, in 2001 the Board of Commissioners authorized the implementation of a comprehensive Clayton County Emergency Operations Plan ("EOP") to ensure the preparedness, mitigation, appropriate response and timely recovery from natural or man-made disasters or emergencies affecting Clayton County; and

WHEREAS, Georgia Emergency Management Agency ("GEMA") made amendments to Georgia's Emergency Operations Plan, said amendments were adopted and revised in November 2019; and

WHEREAS, the County wishes to adopt the amendments to the Georgia Emergency Operations Plan to ensure that the County's EOP is official and compliant with GEMA standards; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served by readopting and amending the EOP for the reasons contemplated herein.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby readopts the Clayton County
Emergency Operations Plan with the amendments and updates required to meet the newly
established federal and state requirements. The Board authorizes the Chairman to perform
any acts necessary to accomplish the intent of this Resolution. The Board further
authorizes the Chief Financial Officer to amend the budget where necessary to reflect an
appropriate revenue source and expense all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the
Board of Commissioners.
