RESOLUTION NO. 2020-159

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH THE CITY OF FOREST PARK FOR USE OF THE COUNTY'S MOBILE STAGE FOR VARIOUS EVENTS; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from the City of Forest Park (the "City") for use of the mobile stage for the City's car and bike show on August 15, 2020; and

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from the City for use of the movie screen for the City's public tailgating experience for football games on September 19, 2020, October 11, 2020, November 14, 2020, and December 6, 2020 (collectively "the Events"); and

WHEREAS, the mobile stage will be utilized between the hours of 8:00 a.m. to 2:00 p.m. on August 15, 2020; and

WHEREAS, the movie screen will be used for 5 hours on September 19, 2020, from 12:00 p.m. to 5:00 p.m. on October 11, 2020, for 5 hours on November 14, 2020, and from 12:00 p.m. to 5:00 p.m. on December 6, 2020.

WHEREAS, the City is requesting to pay a reduced price for the mobile stage fee of (\$600.00) for 6 hours, and a reduced price for the movie screen of (\$350) for 5 hours per requested date, and staff fees of (\$20.00) per employee needed to transport and work the equipment during the Events;

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the mobile stage and movie screen and executing a license agreement for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County (“the County”) to enter into an agreement (“the Agreement”) with the City of Forest Park (“the City”) for use of the County’s mobile stage for the City’s car and bike show on August 15, 2020 and for use of the movie screen for the City’s public tailgating experience for football games on September 19, 2020, October 11, 2020, November 14, 2020, and December 6, 2020 (collectively “the Events”). The Board of Commissioners authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.


Section 2. The City of Forest Park will pay to the County a reduced price for the mobile stage fee of (\$600.00) for 6 hours, and a reduced price for the movie screen of (\$350) for 5 hours per requested date, and staff fees (\$20.00) per employee needed to transport and work the equipment during the Events. Further, the Board of Commissioners hereby authorizes the Chief

Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Agreement.


