RESOLUTION NO. 2020-178

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW CLAYTON COUNTY FIRE AND EMERGENCY SERVICES AND THE EMERGENCY MANAGEMENT AGENCY TO FORMALIZE AN AGREEMENT FOR UTILIZATION OF THE NEIGHBORS BY RING APP TO ASSIST WITH DISSEMINATING EMERGENCY AND SAFETY WITH RESIDENTS AND TO HELP MAKE NEIGHBORHOODS SAFER; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Fire and Emergency Services (“CCFES”) wishes to formalize an agreement for utilization of the Neighbors by Ring (“Ring”) app to assist the Fire Marshal’s Office with videos pertaining to criminal cases, if the user agrees to share the video; and

WHEREAS, the Neighbors by Ring app will also assist the Emergency Management Agency (“Agency”) with disseminating inclement weather information over a geographical area; and

WHEREAS, there is no endorsement or promotion of Ring products or services required; and

WHEREAS, there is no obligation to participate in any other Ring programs; and

WHEREAS, Ring will provide training and ongoing support to the agency; and

WHEREAS, Ring will publicly announce the County’s participation in Neighbors by sending and in-app announcement and adding the County’s name to Ring’s publicly available Active Agency Map; and

WHEREAS, users can deny access to their video footage at any time; and

WHEREAS, by collaborating with Ring and becoming publicly available through the Active Agency Map, this will enhance the County’s ability to potentially gain additional video footage for

potential arson cases, as well as, provide the public with inclement weather updates and safety related material; and

WHEREAS, the County will not incur a financial impact.; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by entering into this agreement for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED




Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


