A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ESTABLISH HOURS OF OPERATIONS FOR CLAYTON COUNTY PARKS AND RECREATION DEPARTMENTS DURING THE HOLIDAYS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Parks and Recreation Department is requesting Board of Commissioners to establish hours of operations for Clayton County Parks and Recreation facilities during the holidays; and

WHEREAS, due to the reduced participation over the past 6 months and the holidays the Parks & Recreation Department would like to propose amended hours; and

WHEREAS, the Clayton County Parks and Recreation Department is requesting the BOC to approve the Holiday Schedule set forth below; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by establishing the holiday hours of operation.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the hours of operations for the Clayton County Parks and Recreation facilities during the holidays set forth below:

November Special Hours

Wednesday, November 25th - 8:00am - 5:00pm
Thursday, November 26th – Closed (Thanksgiving / County Holiday)
Friday, November 27th – Closed (Thanksgiving / County Holiday)
Saturday, November 28th - Closed

December Special Hours

Wednesday, December 23rd - 8:00am - 5:00pm
Thursday, December 24th - Closed (Christmas / County Holiday)
Friday, December 25th - Closed (Christmas / County Holiday)

Saturday, December 26th -- Closed

December / January Special Hours

Thursday, December 31st - 8:00am - 5:00pm

Friday, January 1st - Closed (New Year's / County Holiday)

Saturday, January 2nd - 9:00am - 1:00pm


January 18th - Closed (Martin Luther King Jr. / County Holiday)


