RESOLUTION NO. 2020-222

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ESTABLISH HOURS OF OPERATIONS FOR CLAYTON COUNTY LIBRARY SYSTEM DURING THE HOLIDAYS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Library Services Department (the "Library") is requesting Board of Commissioners to establish hours of operations for Clayton County Library System during the holidays; and

WHEREAS, these hours align with the Library's current limited services operational plan.; and

WHEREAS, this change will provide access to services earlier than the Library's current adjusted public schedule; and

WHEREAS, the Library offers one day of later hours to accommodate the people who need access but are not able to arrive before 5:00pm on the other days during the week; and

WHEREAS, due to COVID-19, limited hours of service and limited access are necessary to minimize the exposure to transmission of the virus; and

WHEREAS, the Library is adjusting the hours to be more in line with similar services in the county and to alert the public about the schedule that we will adhere to during the holiday season; and

WHEREAS, this schedule change should have minimal impact on the public's access to the limited services being offered; and

WHEREAS, the Library is requesting the BOC to approve the Holiday Schedule set forth below; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by establishing the holiday hours of operation.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the hours of operations for the Clayton County Library system during the holidays set forth below:

Staff will observe the 8:00-5:00 hours but our adjusted hours for the public will be

(Friday) November 27th – Closed (**Thanksgiving Holiday**)
(Saturday) & (Sunday) Closed

December

(Monday) December 21st -9:00am – 4:00pm
(Tuesday) December 22nd-11:00am – 7:00pm
(Wednesday) December 23rd- 9:00am – 4:00pm
(Thursday) December 24th- Closed (**Christmas Holiday**)
(Friday) December 25th- Closed (**Christmas Break**)
(Saturday) December 26th Closed
(Sunday) December 27th Closed
(Monday) December 28th- 9:00am – 4:00pm
(Tuesday) December 29th- 12:00am – 7:00pm
(Wednesday) December 30th-9:00am – 4:00pm
(Thursday) December 31st -9:00am – 4:00pm (**New Year's Eve**)

January

(Friday) January 1st- Closed (**New Year's Day**)
(Monday) January 18th – Closed (**Martin Luther King Jr. Day**)




