RESOLUTION NO. 2021 - 26

A RESOLUTION TO INITIATE AN AMENDMENT TO APPENDIX A "ZONING" TO MODIFY ZONING REQUIREMENTS FOR BOARDING HOMES, PERSONAL CARE HOMES AND GROUP HOMES IN THE COUNTY; TO AMEND THE TERM "FAMILY"; TO DEFINE DEVELOPMENT STANDARDS FOR THESE USES; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners has the authority under O.C.G.A. § 36-66-4 to amend its Zoning Ordinance codified in Section 1.1 of Appendix A of the Clayton County Code; and

WHEREAS, the County finds that is in the best interest of the citizens of Clayton County that those sections of the Zoning Ordinance governing requirements for Boarding Homes, Personal Care Homes, and Group Homes, including Article 1, Basics Provisions (Sec. 1.5); Article 3, Zoning Classifications (Sec. 3.1, 3.5, 3.7, and 3.9); Article 6, Development Standards (6.12) be amended; and

WHEREAS, the County finds that is in the best interest of the citizens of Clayton County that the changes to the foregoing Articles and Sections are set forth with specificity to reduce or eliminate any adverse impact of these changes on the surrounding properties; and

WHEREAS, pursuant to Section 1.14(A)(1), the Board of Commissioners deem it in the best interest of the citizens of Clayton County, and the County will best be served by initiating an amendment to Section 1.5 of the Zoning Ordinance to update the definition of

“Family”; and

WHEREAS, the County finds that it is in the best interests of the citizens of Clayton County to amend Sections 3.1, 3.5, 3.7, 3.9, and 6.2 of the Zoning Ordinance to provide amended and updated zoning and development requirements for Boarding Homes, Personal Care Homes, and Group Homes, to authorize development standards associated with such facilities in accordance with the procedures of State law and the Board of Commissioners’ Rules and Procedures.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED


Section 1. Pursuant to provisions of Georgia law and the Clayton County Code of Ordinances, the Board of Commissioners hereby directs appropriate staff to initiate a text amendment to Section 1.5 of Article 1 of the Zoning Ordinance to update the defined word “Family” and to amend Articles 3 Zoning Classifications and Article 6 to regulate the uses and locations of boarding homes, group homes and personal care homes.

Section 2. This Resolution shall become effective upon its approval by the Board of Commissioners.




