RESOLUTION NO. 2021-29

A RESOLUTION AUTHORIZING CLAYTON COUNTY SENIOR SERVICES DEPARTMENT TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE ALZHEIMER'S ASSOCIATION TO PROVIDE EDUCATION AND PROGRAMMING FOR SENIORS AND CAREGIVERS WITHIN THE COUNTY; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Alzheimer's Association has identified Clayton County as a county with an increasing number of seniors and caregivers that have been affected and impacted by dementia and Alzheimer's; and

WHEREAS, the Alzheimer's Association will provide community forums in a virtual town hall style session, support groups, community education, materials to promote a 24/7 helpline, and resources for caregivers available through the Alzheimer's Association's website; and

WHEREAS, the Alzheimer's Association and Senior Services will develop a Caregivers Symposium for family care partners and caregivers to access local and national support services and resources; and

WHEREAS, the Caregivers Symposium will showcase all the resources and services which support those impacted by Alzheimer's and dementia; and

WHEREAS, entering into this Memorandum of Understanding will educate the community, staff, and seniors about Alzheimer's and dementia; and

WHEREAS, caregivers and seniors affected by Alzheimer's and dementia will be provided with the support they so desperately need; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by entering this Memorandum of Understanding for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of Clayton County Senior Services Department, to enter a Memorandum of Understanding with the Alzheimer's Association to provide a consumer education and programming to seniors and caregivers within the county. The Memorandum of Understanding shall be substantially in the form attached hereto as Exhibit A subject to any minor modifications as may be required by the Chief Staff Attorney or Chairman. The Board also authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. Further, the Chairman or his designee is authorized to execute the Memorandum of Understanding.

Section 2. This Resolution and the attached Memorandum of Understanding shall be effective on the date of its approval by the Board of Commissioners.


