RESOLUTION NO. 2021-74

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO GRANT A SPECIAL FACILITY USE REQUEST TO ALLOW YOUTHSERV360, INC. TO OPERATE THE SUMMER FOOD PROGRAM AT SIX CLAYTON COUNTY LIBRARY BRANCH LOCATIONS TO FEED THE YOUTH LIVING NEAR THE SITES; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, during the summer months children are no longer receiving breakfast and lunch at school, many families struggle to feed their children nutritious meals each day; and

WHEREAS, YouthServ360, Inc. would like to operate a Summer Food Program ("SFSP") at six Clayton County Library branch locations to feed the youth living near the sites; and

WHEREAS, YouthServ360's summer meal programs will provide summer meals for children in low-income areas; and

WHEREAS, SFSP will operate at six (6) Clayton County Library System ("CCLS") sites from May 31, 2021, until July 30, 2021, as listed on Attachment A; and

WHEREAS, each CCLS site will have their own site supervisor that serves as the daily point of contact for the meal distribution, and the list of names as well as their contact information can be found on Attachment A; and

WHEREAS, YouthServ360, Inc. will be the exclusive food sponsor for this program and during meal service operation hours, YouthServ360 will provide staff to distribute food and complete the meal counts; and

WHEREAS, adequate supervision of youth will be provided by CCLS when requested;

WHEREAS, YouthServ360, Inc. will keep the CCLS aware of any unforeseen changes in menu with as much notice as possible but will strive for 48 hours; and

WHEREAS, CCLS will provide YouthServ360, Inc. a list of all scheduled closures taking place between May 31, 2021, and July 30, 2021; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by approving the special use facility request for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of Clayton County Library Services, to allow YouthServ360, Inc. to operate a Summer Food Program at six Clayton County Library branch locations to feed the youth living near the sites. The program will run from May 31, 2021, through July 30, 2021, at the sites listed in Attachment A to this Resolution. The Board also authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance and Board of Health food preparation requirements prior to the initial event date as provided by the Clayton County Risk Management Department.
