RESOLUTION NO. 2021-77

A RESOLUTION AUTHORIZING CLAYTON COUNTY SENIOR SERVICES DEPARTMENT TO APPROVE AND SUPPORT A SPONSORSHIP PACKAGE FOR SENIOR SERVICES ANNUAL SIGNATURE MAYFEST EVENT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Senior Services Department is requesting the Board of Commissioners accept a sponsorship package for the Senior Services' annual signature Mayfest event for fiscal year 2021; and

WHEREAS, Mayfest celebrates and honors seniors 55 and older in Clayton County; and

WHEREAS, the funds collected from the sponsorship package will be used to help offset the costs of the event; and

WHEREAS, Mayfest receives over \$15,000 in sponsorship and vendor fees; and

WHEREAS, sponsorship dollars allows the Senior Services department to implement new signature events as the cost of this event will eventually be 100% covered through sponsorships; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by approving and accepting the sponsorship package for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of Clayton County Senior Services department, to approve the sponsorship package for Senior Services' annual Mayfest event. The Board authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the

Chief Financial Officer to amend the budget, where necessary, to reflect an appropriate revenue source and expense, as may be required.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


