RESOLUTION NO. 2021-101

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH BEHAVIOR ANALYSIS AND INTERVENTION CENTER FOR THE PURPOSE OF FACILITATING SENSORY FRIENDLY ACTIVITIES FOR FAMILIES WITH INDIVIDUALS THAT HAVE AUTISM; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Library System (the "Library") wishes to enter into a two year Memorandum of Understanding with Behavior Analysis and Intervention Center, LLC ("BAIC") to facilitate sensory friendly activities for families with individuals that have Autism; and

WHEREAS, through the practice and training of Applied Behavioral Analysis therapy supervised BAIC staff will skillfully teach foundational skills to bring about meaningful growth and change the families; and

WHEREAS, the Library and BAIC shall work together to develop and establish policies and procedures that will promote and sustain a market for BAIC; and

WHEREAS, BAIC will hand out sensory boxes in a drive up format in the parking lot of Northwest Library; and

WHEREAS, the boxes may contain sensory items such as kinetic sand, fidget toys, information on forming learning routines and more; and

WHEREAS, the Library will stay in communication with BAIC regarding dates and timelines in order to deliver materials needed to facilitate the program; and

WHEREAS, this program will skillfully teach foundational skills to bring about meaningful growth and change to the families with individuals that have Autism and similar disabilities; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the memorandum of understanding with Behavior Analysis and Intervention Center, LLC for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Memorandum of Understanding with Behavior Analysis and Intervention Center, LLC to facilitate sensory friendly activities for families with individuals that have Autism. The Memorandum of Understanding shall be in substantially the form attached, hereto as Exhibit "A", subject to such minor changes, insertions, or deletions as the County Attorney and or Chairman of the Board of Commissioners may approve. The Board of Commissioners hereby authorizes the Chairman, or his designee, to execute the Agreement, with such minor changes, insertions, or deletions, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
