RESOLUTION NO. 2021-156

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE CITY OF JONESBORO TO FORMALIZE THE PROCESS BY WHICH CLAYTON COUNTY WILL ASSUME INSPECTION RESPONSIBILITY FOR THE CONSTRUCTION OF THE NEW COUNTY FUELING STATION; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County wishes to enter into a Memorandum of Understanding with the City of Jonesboro ("City") to formalize the process by which Clayton County will assume inspection responsibility for the construction of the new County Fueling Station located at 1030 Post Way, Jonesboro, Georgia 30236 within the City Limits of Jonesboro ("Project"); and

WHEREAS, during the Inspection Portion of the Project, the City will transfer its rights and responsibilities as the host jurisdiction of the Project to the County; and

WHEREAS, the City will relinquish any responsibilities including the collection of any fees associated with inspections and permits to the County and will not assume any liability as a result of the County assuming responsibility of the Inspection Portion of the Project; and

WHEREAS, the County will assume all responsibility during the Inspection Portion of the Project and will not be required to submit any fees associated with the Inspection Portion of the Project to the City; and

WHEREAS, the County shall ensure the Project is constructed and maintained in accordance with the City Code; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the memorandum of understanding with the City of Jonesboro for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Memorandum of Understanding with the City of Jonesboro ("City") to formalize the process by which Clayton County will assume inspection responsibility for the construction of the new County Fueling Station located at 1030 Post Way, Jonesboro, Georgia 30236. The Memorandum of Understanding shall be in substantially the form attached, hereto as Exhibit "A", subject to such minor changes, insertions, or deletions as the County Attorney and/or Chairman of the Board of Commissioners may approve. The Board of Commissioners hereby authorizes the Chairman, or his designee, to execute the Agreement, with such minor changes, insertions, or deletions, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
