RESOLUTION NO. 2021 - 177

A RESOLUTION TO AUTHORIZE CLAYTON COUNTY TO ACCEPT TITLE TO A 2015 CHEVROLET TAHOE DONATED TO THE COUNTY FOR COUNTY USAGE; TO AUTHORIZE THE VEHICLE FOR COUNTY USAGE AND ASSIGN THE VEHICLE TO THE CLAYTON COUNTY SHERIFF'S OFFICE; TO AUTHORIZE THE CHAIRMAN, CENTRAL SERVICES AND FLEET MAINTENANCE TO TAKE ALL ACTIONS NECESSARY TO ACHIEVE THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Sheriff's Office wishes to accept the title of a vehicle that the owner wants to donate for County usage and have the vehicle assign to its department; and

WHEREAS, the requested vehicle is for a black in color, 2015 Chevrolet Tahoe, V.I.N. 1GNSK2EC9FR581835, with approximately 92504 miles, with a clean title with no liens; and

WHEREAS, the vehicle is already equipped with emergency equipment that includes lights, a siren, a transporting cage, and a push bumper; and

WHEREAS, the vehicle has been inspected by the Clayton County Fleet Department and has passed all inspections; and

WHEREAS, there is no financial impact to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by placing said vehicle in the Clayton County Department's Fleet for use by the Sheriff's Office in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept title to a 2015 Black Chevrolet Tahoe, V.I.N. 1GNSK2EC9FR581835 and to assign said vehicle to the Clayton County Sheriff's Office for the purpose of enhancing law enforcement.

Section 2. The Board of Commissioners authorizes the Chairman, Central Services, and Fleet Maintenance to perform all acts necessary to affect this resolution.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


