RESOLUTION NO. 2021-220

A RESOLUTION AUTHORIZING THE CLAYTON COUNTY SENIOR SERVICES DEPARTMENT TO ACCEPT GRANT FUNDING FROM THE ATLANTA REGIONAL COMMISSION TO PROVIDE NUTRITION SERVICES TO THE HOME DELIVERED MEAL PROGRAM FOR ADULTS AGE 60 AND OLDER UNDER THE CONSOLIDATED APPROPRIATIONS ACT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County, through the Clayton County Senior Services Department, seeks authorization from the Clayton County Board of Commissioners to accept grant funding from the Atlanta Regional Commission (“ARC”) to provide home delivered meals under the Consolidated Appropriations Act (“CAA”) in the amount of \$38,917.00; and

WHEREAS, Clayton County Seniors have been adversely impacted by Covid-19; and

WHEREAS, the funds will assist the Senior Services Department address the needs of 30-50 seniors who are on the Tier 1 waiting list for Home Delivered Meals; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and that the County will best be served by allowing the County to apply and if awarded accept the grant funding for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, through the Clayton County Senior Services Department, to accept grant funding from the Atlanta Regional Commission to provide to provide home delivered meals under the Consolidated Appropriations Act in the amount of \$38,917.00; and

Section 2. The Board of Commissioners hereby authorizes the Chairman to execute the Agreement and to perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required by the grant.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




