RESOLUTION NO. 2021 - 240

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LOCATION AGREEMENT WITH REPTILE MOVIE, LLC, PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH CLAYTON COUNTY PROPERTY WILL BE USED FOR THE PURPOSE OF PARKING AND CATERING; TO AUTHORIZE THE CHAIRMAN, OR HIS DESIGNEE, TO EXECUTE THE LOCATION AGREEMENT AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Reptile Movie, LLC, (the "Company") wishes to utilize Clayton County property, land and facilities, located at Clayton County International Park in Jonesboro, Georgia (the "Location") for the purpose of parking and catering; and

WHEREAS, the Company wishes to utilize the Location beginning on November 3, 3031 through November 10, 2021, at rates outlined in a Location Agreement; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by entering into a Location Agreement with the Company for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Location Agreement with Reptile Movie, LLC, providing for the terms and conditions

under which the Company will be allowed to use the Clayton County, property, land and facilities located at Clayton County International Park in Jonesboro, Georgia for the purpose of parking and catering beginning on November 3, 2021, through November 10, 2021, or such date as authorized by the Chairman or his designee.

Section 2. The Board of Commissioners hereby authorizes the Chairman or his designee to execute any agreements and to perform all other acts necessary to accomplish the intent of this Resolution. The Board of Commissioners further authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Agreements.


Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


