RESOLUTION NO. 2021 – 275

A RESOLUTION AUTHORIZING THE CLAYTON COUNTY BOARD OF COMMISSIONERS TO ADOPT THE CLAYTON COUNTY FIRE & EMERGENCY SERVICES 2021-2026 STRATEGIC PLAN; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Fire & Emergency Services (“CCFES”) provides an all-hazards approach in protecting the lives and property of the residents, businesses, and visitors of Clayton County, Georgia; and

WHEREAS, CCFES is consistently working to achieve and maintain the highest level of professionalism and efficiency on behalf of those it serves, and thus, contracted with the Center for Public Safety Excellence (“CPSE”) to facilitate a method to document the department’s path into the future through a Community-Driven Strategic Plan; and

WHEREAS, the following strategic plan was written with a basis in the Commission on Fire Accreditation International’s (“CFAI”) fire and emergency service accreditation model and is intended to guide the organization within established parameters set forth by the authority having jurisdiction; and

WHEREAS, the 2021-2026 strategic plan will guide the organization and ensure that the goals and objectives outlined therein will ensure the expectations of the community are met and serve as the foundation of the organization’s application for re-accreditation in 2022; and

WHEREAS, CCFES is requesting the Board of Commissioners accept the Strategic Plan as presented; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by approving the Clayton County Fire & Emergency Services 2021-2026 Strategic Plan.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the approval of the Clayton County Fire & Emergency Services 2021-2026 Strategic Plan prepared for the County. The plans are attached to this Resolution as Exhibit A. The Board of Commissioners also hereby authorizes the Chairman to execute any documents required for implementation of these Plans and to perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.
