RESOLUTION NO. 2021-285

A RESOLUTION AUTHORIZING CLAYTON COUNTY THROUGH ITS SENIOR SERVICES DEPARTMENT TO ACCEPT FUNDS FROM COMCAST FOR THE FLINT RIVER COMMUNITY CENTER; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County, through the Clayton County Senior Services Department, seeks authorization from the Clayton County Board of Commissioners to accept a \$15,000.00 donation from Comcast located in Norcross, GA. to be donated to Flint River Community Center; and

WHEREAS, accepting the donation will allow Flint River Community Center to enhance the educational content, including digital skills and workforce readiness programming, available at the Lift Zone; and

WHEREAS, funding for this grant will provide educational content, including digital skills and workforce readiness programming; and

WHEREAS, there is no financial impact to the county; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and that the County will best be served by accepting the Comcast donation for the above stated purpose.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED




Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


