RESOLUTION NO. 2022-49

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPLY FOR AND, IF AWARDED, ACCEPT THE PROMOTING SAFE AND STABLE FAMILIES GRANT FUNDS FOR THE KINSHIP CARE RESOURCE CENTER; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE SERVICE ORDER AGREEMENT; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Senior Services Department is seeking approval to apply and, if awarded, accept the Promoting Safe and Stable Families (“PSSF”) grant funds for the Kinship Care Resource Center; and

WHEREAS, approval to apply and accept the PSSF grant will allow Kinship Care to continue providing programs such as tutoring, parent education workshops, information and referral services and support groups for grandparents and relative caregivers; and

WHEREAS the amount requested is as follows:

Federal (75%)- \$75,000;

Required Cash Match (25%)- \$25,000;

Total Cost of Services (100%)- \$100,000; and

WHEREAS, there is no financial impact to the County as the grant allows staff salaries to be used as the match; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by applying and accepting the grant for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to apply and, if awarded, accept the Promoting Safe and Stable Families ("PSSF") grant funds for Kinship Care Resource Center. The Board authorizes the Chairman to otherwise perform all acts necessary to carry out the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


