RESOLUTION NO. 2022-70

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH TUSKEGEE AIRMEN AVIATION AND STREAM TRAINING TO EXECUTE THE AVIATION-BASED YOUTH PROGRAM IN COMMUNITY SETTINGS; TO AUTHORIZE THE COUNTY TO HOST THE AVIATION YOUTH PROGRAM AT COUNTY LIBRARY LOCATIONS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Library System (the “Library”) wishes to enter into a Memorandum of Understanding (“MOU”) with Tuskegee Airmen Aviation and Stream Training (“TAAST”) to execute the aviation-based youth program in community settings; and

WHEREAS, TAAST provides resources to support student engagement understanding and exposure to and in aviation/aerospace curriculum and interactive experiences; and

WHEREAS, students will have the opportunity to participate in the CCLS Drone Program (and other available STEM-related) experiences; and

WHEREAS, youth interested in aviation, aerospace and stream careers will get hands-on experience and exposure to the career opportunities in aviation; and

WHEREAS, the youth will have the opportunity to experience drones, robotics, coding, programming, discovery flights, aviation history, flight simulator orientation, aviation careers, an introduction to aerodynamics, field trips, and interaction with personnel involved in a variety of aviation/aerospace careers; and

WHEREAS, there is no cost to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the Memorandum of Understanding with Tuskegee Airmen Aviation and Stream Training for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Memorandum of Understanding with Tuskegee Airmen Aviation and Stream Training to execute the aviation-based youth program in community settings. The Memorandum of Understanding shall be in substantially the form attached hereto as Exhibit "A", subject to such minor changes, insertions, or deletions as the County Attorney and/or Chairman of the Board of Commissioners may approve. The Board of Commissioners further authorizes the Library to host this training for youth interested in aviation careers at the County's library locations. The Board of Commissioners hereby authorizes the Chairman, or his designee, to execute the Agreement, with such minor changes, insertions, or deletions, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
