RESOLUTION NO. 2022- 137

A RESOLUTION AUTHORIZING CLAYTON COUNTY, THROUGH THE CLAYTON COUNTY FIRE & EMERGENCY SERVICES, TO APPLY FOR, AND IF AWARDED, ACCEPT FUNDING FROM THE GEORGIA TRAUMA COMMISSION FOR TRAUMA RELATED EQUIPMENT FOR CLAYTON COUNTY'S GROUND AMBULANCES; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO EXECUTE THE GRANT AGREEMENT AND OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County ("County"), through the Clayton County Fire & Emergency Services, wishes to apply for and, if awarded, to accept funds from the Georgia Trauma Commission for trauma related equipment for the County's ground ambulances in the amount of \$25,155.48; and

WHEREAS, the Georgia Trauma Commission approved a grant award opportunity with AFY 2022 funding to be used for the purchase of Trauma Related Equipment to equip ambulances; and

WHEREAS, there is no financial cost to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by applying for, and if awarded, accepting the grant for the stated purposes.


NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF  
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section I. The Board of Commissioners hereby authorizes Clayton County to apply for, and if awarded, accept funds from the Georgia Trauma Commission for trauma related equipment for the County's ground ambulances in the amount of \$25,155.48. The Board of Commissioners authorizes the Chairman to execute the Agreement, and otherwise to perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto.


Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.
